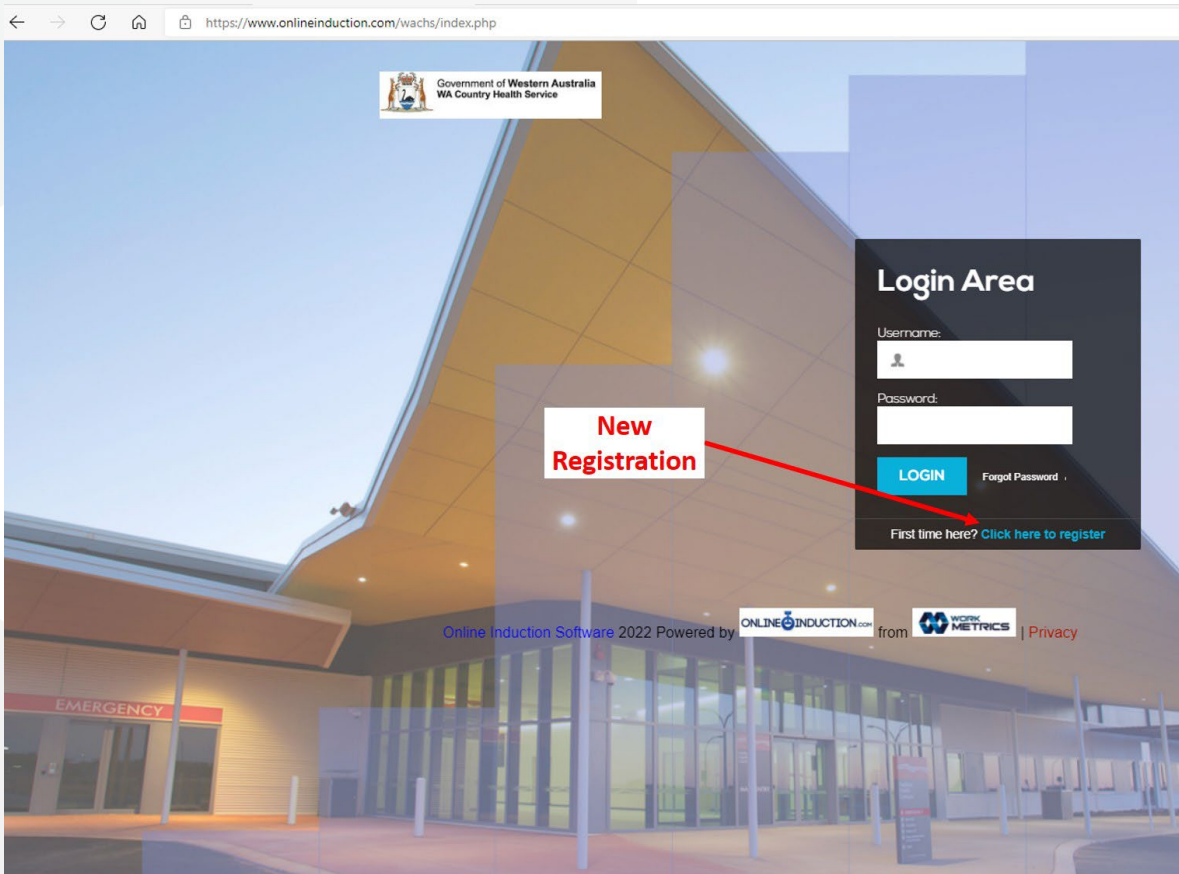




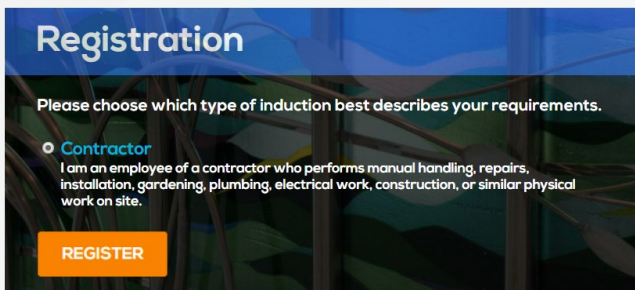
WACHS Online Contractor Induction (OCI) Contractor Registration & Induction Guide

1. Use Google Chrome or Microsoft Edge (Do Not use Internet Explorer)

2. Click the **Click here to register** link



3. Click **Register**



4. Complete the registration section.

Note:

- **Your Company** - If your company does not appear in the drop-down list, you or your company representative will need to register for a company account in the OCI portal before contractors are able to register and complete their inductions. Please refer to the [Company Registration Guide](#) for instructions how to register for a company account.
- **Your Email** – The Email address you enter will become the username to log in contractor account. If you are a sole trade or a company representative who is also a contractor to attend WACHS sites, you will need to use a different email address from your company account to register for your contractor account.
- **Region** – You must select a Primary Region. If you work in multiple regions, you can select other regions under “Please choose other regions that you provide services to”.

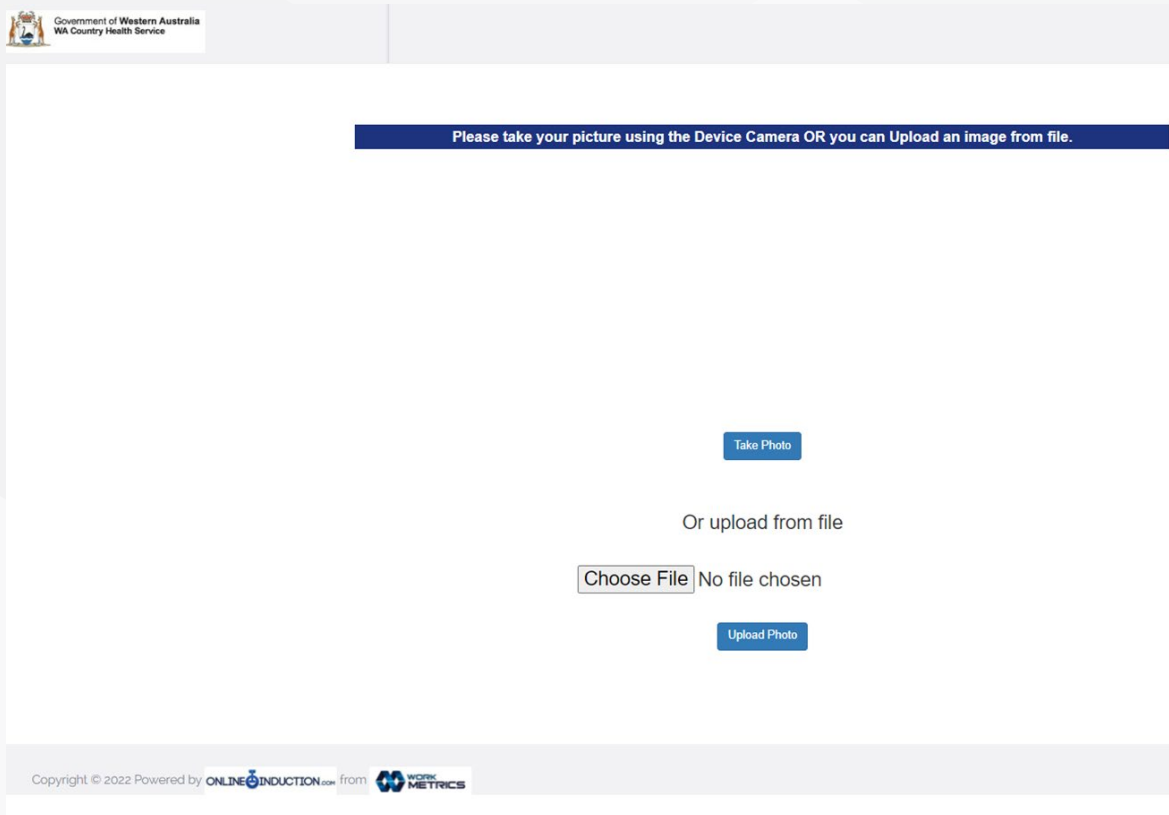

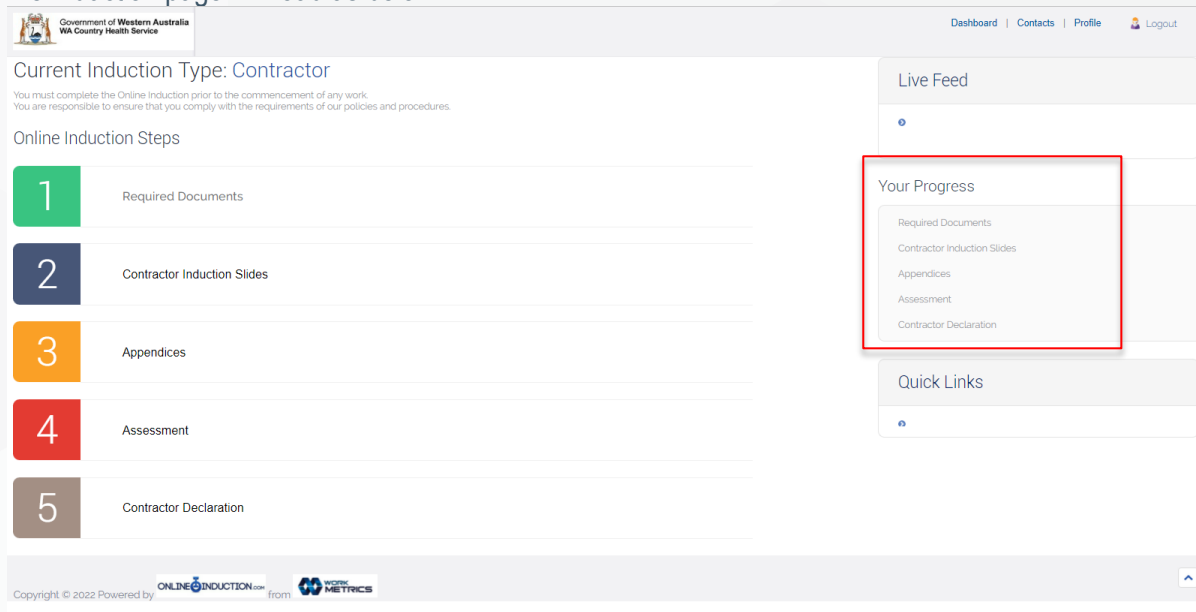

8. Step 1 – Required Documents

Complete the section and upload:

- i) Blue Card or White Card (if applicable)
- ii) National Police Clearance (MANDATORY REQUIREMENT FOR ALL CONTRACTORS) – certificate number, issue date – Certificate must be less than 12 months since issue date. Please also upload the certificate
- iii) COVID-19 Vaccination (if requested by regional WACHS contact) – dates and upload certificate
- iv) Influenza Vaccination (if requested by regional WACHS contact) – date and upload certificate
- v) Trade licenses, Tickets and Certificates (Mandatory for all documentation related to your trade onsite) – upload document and add expiry dates

PLEASE NOTE: Document file names must not contain more than one period “.” as the system will not upload for security reasons. Please remove all additional periods before uploading

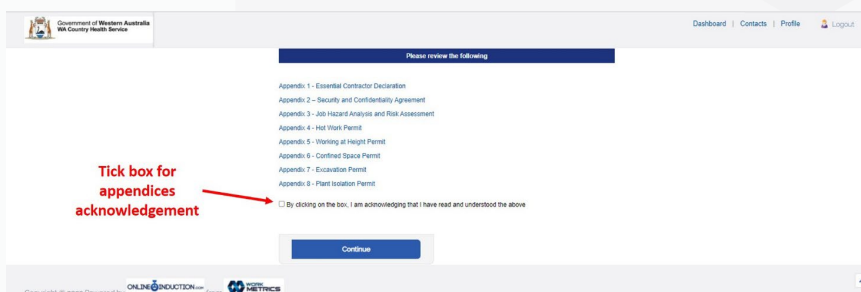


Read through each section and click **Next** to continue

11. **Step 4 - Assessment**

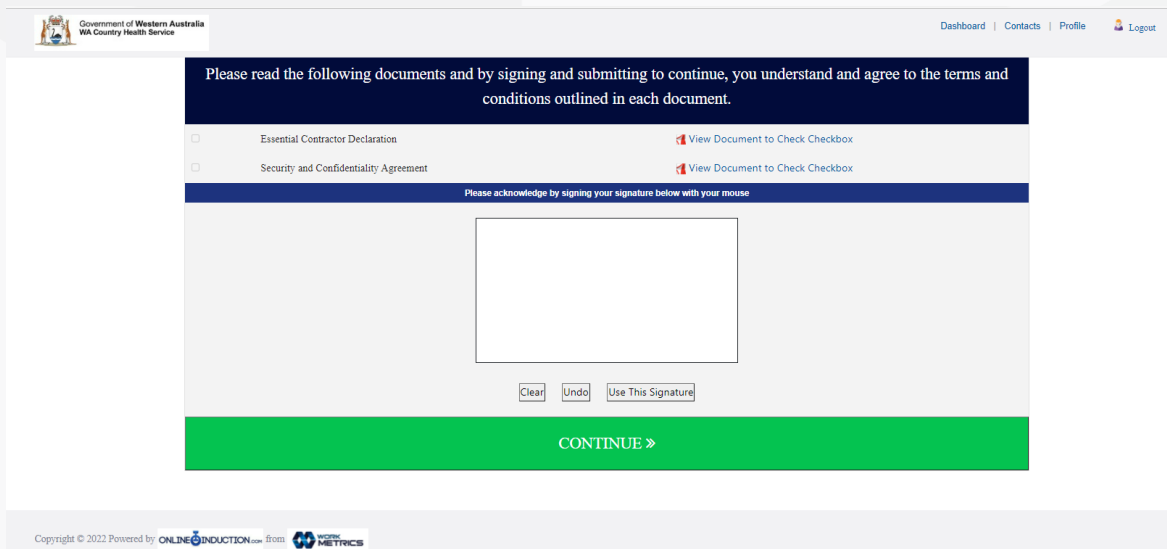

Click on the link for the two declarations required for contractor induction:

- i. Essential Contractor Declaration
- ii. Security & Confidentiality Agreement

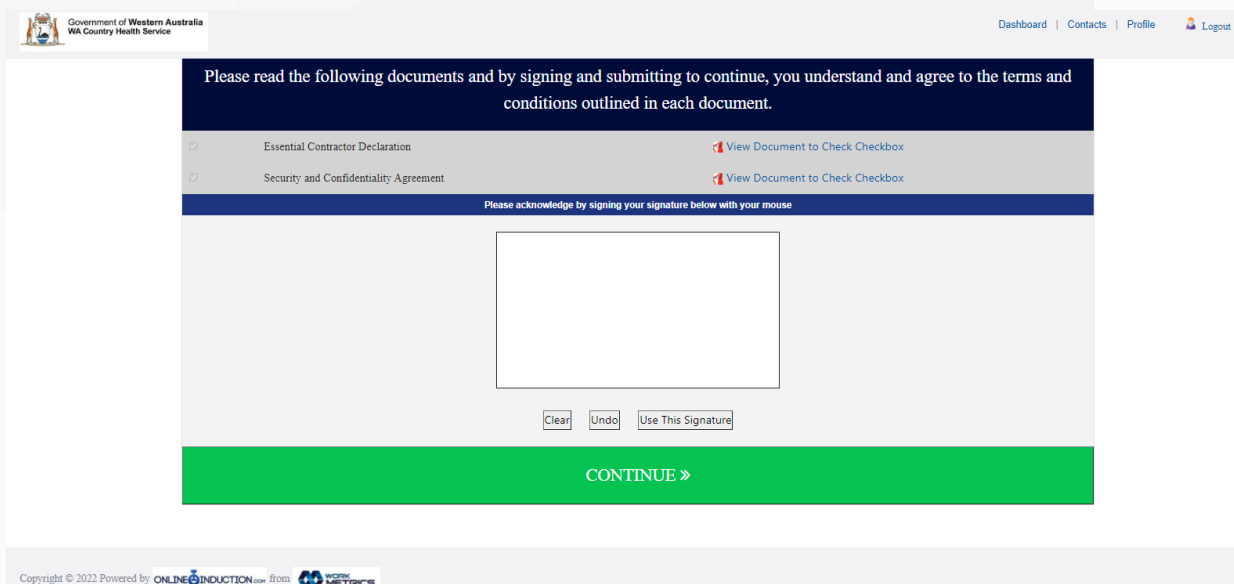
You are required to read each declaration.

Sign the signature box and click Use this Signature to acknowledge you have understood and agree to the terms and conditions outlined in each document.

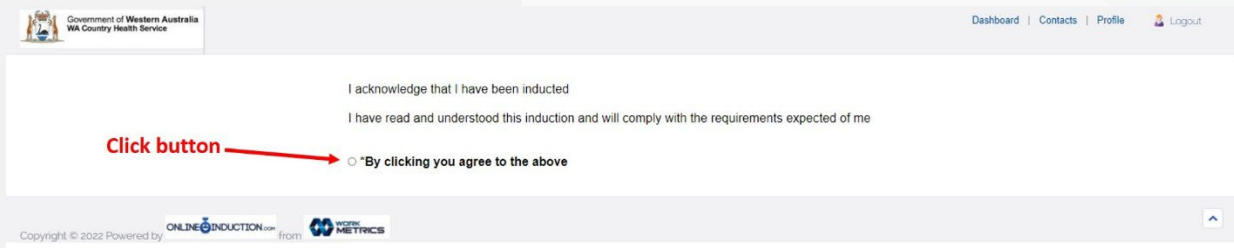

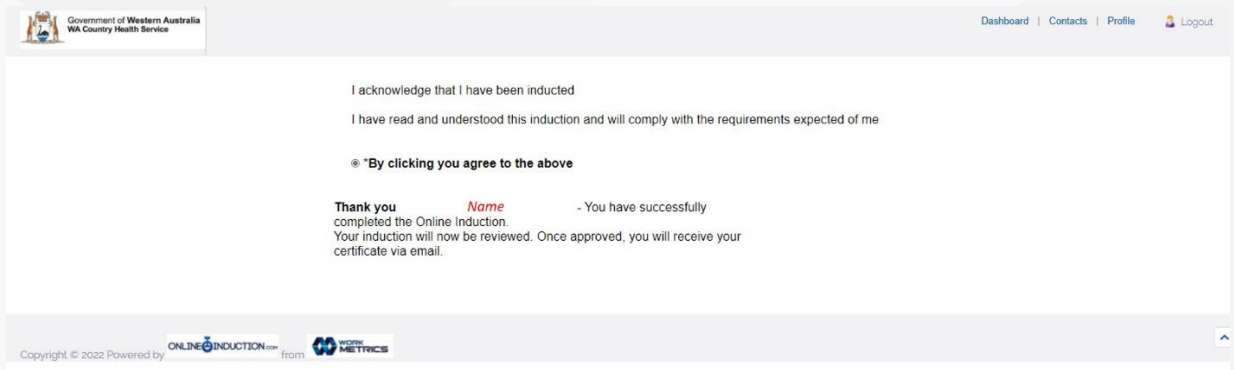
13. Acknowledgement:
